Semi-official course description: Limits, derivatives, techniques of differentiation, trigonometric functions, curve sketching, applications of the derivative, integrals, applications of the integral.

Text: *Calculus* (9th edition) by Stewart, Clegg, and Watson with WebAssign (Class key: None)

Grading scheme: Your grade in this class will be based on your demonstration of calculus skills, not on a point system! Here's how you can demonstrate those skills:

Learning Targets: We have 30 Learning Targets in this class, 10 of which are Core Learning Targets and 20 of which are Other Learning Targets. You'll have multiple chances to demonstrate your understanding of each Learning Target on regular quizzes and individual reassessments, and there's no penalty for needing multiple chances. Learning doesn't happen immediately, and this way your final grade will reflect how well you understand the material and the skills you've acquired by the end of the semester. It's all right to make a mistake and try again!

The quizzes will be on **February 11, March 4, April 1, and April 29**, and there will be an optional final exam (**date TBA**). I'll only reschedule the final if you have a documented emergency or unless you make alternate arrangements with me by Monday, April 20. Note that I will only make these arrangements in the event of extenuating circumstances beyond your control. You'll submit your homework through WebAssign. These problems will be assigned at the end of each class day and will be due at the start of class a week after we finish covering the relevant material (so problems covering the material we finish on a Monday will be due the next Monday and so on). You'll only be able to submit the assignment while the problem set is open unless you request a due date extension.

To earn an Expert rating on a Learning Target, you need to earn a Satisfactory on that Learning Target on two different quizzes. To earn a Proficient rating on a Learning Target, you only need to earn a Satisfactory on it on one quiz.

If you have component grades that are more than one letter grade apart, I'll ask you to submit a grade proposal at the end of the semester. You need to have earned at least 9 Satisfactories on Core Learning Target questions to be able to take the final; I may approve exceptions.

Please note that you must complete all 8 LF and D Core Learning Targets at the Expert level and both I Core Learning Targets at the Proficient level to receive a C- or higher in the course.

Calculator policy: You are permitted to use any scientific or four-function calculator you like on quizzes and the final exam, but not a graphing calculator. You are allowed to use any kind of calculator you like when you do your work in WebAssign, but I suggest you use a calculator you're allowed to use on quizzes and the final so you'll be familiar with it then.

Academic honesty: You are expected to follow the Hofstra University Honor Code at all times. All forms of academic dishonesty are serious ethical and professional infractions.
